FY 2013 awards

A report of year-to-date expenditures will be given at the next Provider meeting. David explained to the new Prevention providers that this is monthly report given by the Fiscal staff that shows the dollar amount and percentage of funds exhausted by providers in each of their service categories. The grantees office will make reallocation recommendations at the Planning Council meeting on January 23rd. It is estimated that there will be approximately \$80,050 to reallocate to different service categories and providers.
