- A. Discussed Prevention: Home HIV Testing, Condom mail out, U = U, PREP (No new update)
- B. Discussed Memphis TGA Ryan White Part A & MAI Early Intervention Services (EIS) Service Standards cont'd:
  - Committee members approved changing the verbiage for linkage to care from 45 to 30 days of diagnosis or reengagement for newly diagnosed individuals or individuals out of care.
  - Recommendation by Jennifer Warren to include the verbiage in Option 2 for the sentence to now read: "In each area the EIS Specialist is focused on identifying and making the necessary referrals pertaining to the specific barriers the client has and or may experience in accessing medical care, remaining in care, and or adhering to medical treatments."
  - Recommendation by Tarsha Taylor to remove the bullet point regarding psychosocial service standard. The recommendation has been tabled until further discussion is completed.
  - ➤ Committee members agreed that the acronym HIV be updated to reflect PLWHA within the Service Eligibility Service Standards.
  - ➤ Committee members agreed to change the Assessment category to reflect EIS Intake and the Psychosocial Assessment bullet point be changed to Agency Intake.
  - ➤ Motion by Jennifer Warren and proper second by Judah Lenson to vote to create a subcommittee to clarify the EIS Service Standards language and to bring recommended changes before the Evaluation Committee as a whole. Yay – 4, Nay – 0, Abstention – 4 by Tarsha Taylor, Tomekicia Wren, Melissa Wright and Tanyelle Dunlap
  - > The votes were tied; therefore, Tarsha Taylor made the deciding vote of yay to create a sub-committee.
  - ➤ Per Tarsha Taylor, the chair committee, five volunteers are needed for the sub-committee. Jennifer Warren, Judah Lenson, Tomekicia Wren, Tarsha Taylor and Tanyelle Dunlap all volunteered to be part of the sub-committee.
